# HAMILTON ROWING CLUB INC

## CODE OF CONDUCT

I agree as a Member/Affiliate Member of the Hamilton Rowing Club Inc to conduct myself in the spirit of good sportsmanship\*, both on and off the water. I shall adhere to the Club's rules and regulations (including safety rules) and I accept that in the event of breaches of these rules, the Club Captain and/or the Executive Committee has the right to impose certain penalties as deemed appropriate.

I recognize that unacceptable behaviour or actions on my part whilst representing the Hamilton Rowing Club Inc will result in disciplinary actions, and if serious, may result in my suspension or removal from the Club or Committee. Such actions include but are not limited to:

- Failure to pay fees on a timely basis;
- Breaches of Club rules and protocol;
- Engaging or encouraging conduct which may harm the reputation of the Club;
- Repeated un-sportsman-like behaviours, particularly when wearing Club colours;
- Unfounded malicious or libellous remarks about the Club or its officers;
- Criminal conduct or violence of any kind on the Club premises or while representing the Club by wearing Club colours;
- Abuse of trust in matters relating to the Club's monies, plant or equipment.

I accept that the Executive Committee will treat any matters of discipline in a fair manner and allow any member charged with a breach of conduct to present a written appeal of a membership decision in person with a representative should the member so chose, and that the Executive Committee will consider such appeals in the strictest confidence. The Executive Committee decision will be final.

I also recognize that as a club member I have an obligation to take part in all aspects of club operations, including boat loading, fundraising, and plant and property maintenance.

*\*Sportsmanship is defined as respect for one's opponent, coach, teammates and peers, and graciousness in playing, training, winning or losing. Unsportsmanlike behaviour includes any disrespect towards any of the previously mentioned associates, using foul language in an argument with a person in authority, or conducting oneself in a manner not befitting the circumstances or environment of the sport.*
